Braintree Farmers' Market vendor commitment will total approximately 30 farms/artisans. Vendors will be selected on a case-by-case basis by the quality of products and how they complement the market. The deadline for applications and space payments is April 3rd, 2025. ### Time & Dates:

Braintree Farmers Market (BFM) will be held each Saturday morning from 9:00 am to 1:00 pm, *rain or shine*, beginning June 14, 2025 and ending October 11, 2025 with a Thanksgiving Holiday Market on November 22, 2025, for a total of nineteen (19) Saturdays for the 2025 season. Braintree Farmers Market, Inc. will provide an on-site Market Manager and Cashier for Market Moolah for each week the market is held. The Market Manager will be on site starting at 7:30 am for market set up.
